**Council Vice-President:**

Connie Pollock nominated Arlene Tomich

Dave Tamasy appointed Council Vice President by roll call vote with: Tamasy Sr., Tamasy Jr., Popovich and Krasnevich voting yes and Tomich, Pollock and Berarducci voting no.

**Chairman Pro Tem:**

Charles Popovich nominated David Tamasy.

Mayor Popovich called for additional nominations.

David Tamasy appointed Chairman Pro Tem by roll call vote with: Tamasy Sr., Tamasy Jr., Popovich, Pollock and Krasnevich voting yes, Tomich voting no and Berarducci abstaining.

**Motion 01-01** was made by Councilman Tamasy Jr. to appoint Timothy Witt as Borough Solicitor at a rate not to exceed current Solicitor. Second made by Tamasy Sr. Motion adopted by roll call vote with Krasnevich, Popovich, Tamasy Jr., Tamasy Sr. voting yes and Tomich, Pollock and Berarducci voting no.

**Motion 01-02** was made by Councilman Tamasy Sr. to appoint officer on duty during Council meetings as Borough Sergeant of Arms. Second made by Popovich. Motion adopted by roll call vote with Krasnevich, Popovich, Tamasy Jr., Tamasy Sr. voting yes and Tomich, Pollock and Berarducci voting no.

**Motion 01-03** was made by Councilman Krasnevich to retain Lennon, Smith, Souleret Engineering for a period of one year. Second made by Tamasy Jr. Motion adopted by roll call vote with Tamasy Sr., Tamasy Jr., Popovich, Krasnevich Pollock and Berarducci voting yes and Tomich voting no.

**Motion 01-04** was made by Councilman Tamasy Jr. to retain the services of Cypher & Cypher for one year. Second made by Popovich. Motion adopted by unanimous roll call vote.

**Motion 01-05** was made by Councilman Krasnevich to appoint David Tamasy as representative to Regional Tax Collection Authority, Dave Tamasy as alternate. Second made by Popovich. Motion adopted by roll call vote with Krasnevich, Popovich, Tamasy Sr, Tamasy Jr. Pollock and Berarducci voting yes and Tomich abstaining.

**Motion 01-06** was made by Councilman Popovich to reopen 2018 budget and repeal Tax Ordinance. Second made by Tamasy Sr. Motion adopted by roll call vote with Krasnevich, Popovich, Tamasy Jr., Tamasy Sr., Tomich and Pollock voting yes and Berarducci voting no.

**Motion 01-07** was made by Councilman Krasnevich to retain Paul Williams as EMA director. Second made by Tamasy Jr. Motion adopted by unanimous vote.

**Motion 01-08** was made by Councilman Tamasy Jr. to hold work sessions on the first Tuesday and voting meetings on the second Tuesday of each month beginning at 6:30 p.m. Second made by Popovich. Motion adopted by roll cal vote with Krasnevich, Popovich, Tamasy Jr., Tamasy Sr., Tomich and Pollock voting yes and Berarducci voting no.

**Motion 01-09** was made by Councilman Krasnevich to adjourn the meeting at 5:20 p.m. Second made by Tamasy Sr Motion adopted by unanimous vote.
