

ORDINANCE NO. 1958-10

AN ORDINANCE LIMITING PARKING TO TWO (2) HOURS ON VINE STREET, BETWEEN SOUTH FIRST STREET and SOUTH FIFTH STREET IN THE BOROUGH OF WEST NEWTON, WESTMORELAND COUNTY, PENNSYLVANIA, FROM EIGHT O'CLOCK A. M. TO SIX O'CLOCK P. M., EXCEPT ON SUNDAYS.

BE IT ORDAINED AND ENACTED by the Burgess and Town Council of the Borough of West Newton, Westmoreland County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same:

SECTION 1: That parking on Vine Street, between South First Street and South Fifth Street in the Borough of West Newton, between the hours of 8:00 o'clock A. M. and 6:00 o'clock P. M., except Sundays, shall be limited to two (2) hours.

SECTION 2: Any person violating any portion of this ordinance, upon conviction thereof, shall be fined not less than (\$1.00)- ONE DOLLAR and not more than Ten (\$10.00) Dollars and costs of prosecution; and in default of payment of such fine, to imprisonment in the County Jail for not more than ten (10) days.

SECTION 3: Any ordinance or part of ordinance inconsistent herewith is hereby repealed.
