

## ORDINANCE NO. 1959-7

## AN ORDINANCE PRESCRIBING PARKING REGULATIONS AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF.

BE IT ORDAINED AND ENACTED by the Burgess and Town Council of the Borough of West Newton, County of Westmoreland and Commonwealth of Pennsylvania, and it is hereby ordained and enacted by the authority of the same:

SECTION 1. Parking shall be prohibited at all times on the following streets or portions thereof:

(a) On West side of First Street between Robertson Street and Cross Street.

(b) On East Side of First Street between Cross Street and Coopers Alley.

(c) On Poplar Street between North Water Street and North Second Street.

(d) On East side of South Water Street between Vine Street and Main Street.

(e) On East side of North Water Street between Coopers Alley and Robertson Street.

(f) On West side of North Water Street between Coopers Alley and B & O Railroad Crossing.

(g) On West side of South Water Street for a distance of 250 feet South of Main Street.

(h) On West side of South Second Street for a distance of 185 feet North of Vine Street.

(i) On West side of North Second Street for a distance of 126 feet north of Main Street.

(j) On West side of North Second Street for a distance of 72 feet North of Cross Street.

(k) On West Side of South Second Street for a distance of 55 feet South of Main Street.

(l) On West side of Walnut Lane for a distance of 230 feet North of West Main Street.

(m) On East and West sides of Vernon Drive for a distance of 175 feet South of West Main Street.

(n) On North side of West Main Street for a distance of 125 feet West of Walnut Lane.

(o) On North and South sides of Allison Street for a distance of 450 Feet East of Monath Street.

(p) On South side of Main Street for a distance of 50 feet East of South Second Street.

(q) On North Side of Main Street between Third Street and Fourth Street.

(r) On South side of Main Street for a distance of 50 feet East of South Water Street.

(s) On East and West sides of Venable Street between West Main Street and Maple Street.

Section 2. Parking is prohibited on the East side of Walnut Lane for a distance of 230 feet from West Main Street from 8:00 a. m. to 4:00 p. m. on school days.

Section 3. Any person who shall violate any of the provisions of this Ordinance shall upon conviction thereof before the Burgess or a Justice of the Peace, be sentenced to pay a fine of not less than ONE (\$1.00) DOLLAR or more than TEN (\$10.00) DOLLARS and costs of prosecution and in default of payment of such fine and costs to imprisonment in the County Jail for not more than five (5) days.

Section 4. All Ordinances or parts of Ordinances inconsistent herewith be and the same are hereby repealed.
