RESOLUTION 2004-2

A RESOLUTION ACCEPTING A REGIONAL COMPREHENSIVE PLAN AS DEVELOPED BY THE  
TWIN RIVERS COUNCIL OF GOVERNMENTS

**WHEREAS**, the Twin River Council of Governments (“TRCOG”), through its Regional Planning Commission, has developed a Regional Comprehensive Plan (the Plan of a geographic area including the Borough of West Newton); and

**WHEREAS**, on December 9, 2002, the Borough of West Newton executed an Intergovernmental Cooperation Agreement providing for participation in the said Plan; and

**WHEREAS**, development of the Plan has been funded with grants-in-aid from the Department of Community and Economic Development of the Commonwealth of Pennsylvania and the Allegheny County Department of Economic Development as well as funding from other participants in the Regional Comprehensive Plan; and

**WHEREAS**, a final draft of the Plan has been prepared and submitted to each participating municipality for adoption; and

**WHEREAS**, the Twin Rivers Regional Planning Commission approved the Plan following a public meeting on November 20, 2003; and

**WHEREAS**, the Twin Rivers Regional Planning Commission has sent the Plan to the County of Allegheny and to contiguous municipalities and school districts for comments as required by Section 302 of the Pennsylvania Municipalities Planning Code (“MPC”); and

**WHEREAS**, forty five days have elapsed from the submission of the Plan for comments; and


**WHEREAS**, on March 8, 2004, the Council of the Borough of West Newton held a public hearing on the Plan pursuant to public notice; and

**WHEREAS**, all other action required for adoption of a comprehensive plan under Section 302 of the MPC have been taken;



- v. This policy may be adjusted on a case by case review by council to account for special circumstances.


