A RESOLUTION OF THE BOROUGH OF WEST NEWTON, WESTMORELAND COUNTY,PENNSYLVANIA TO TERMINATE EXISTANCE OF THE MUNICIPAL AUTHORITY OF THE BOROUGH OF WEST NEWTON.

WHEREAS, The Borough of West Newton, is a public body, politic and corporate, organized and validly existing under the laws of the Commonwealth of Pennsylvania; and

WHEREAS, The Borough of West Newton has received documentation from the Municipal Authority of The Borough of West Newton, Westmoreland County, Pennsylvania, requesting that its existence as a Municipal Authority under the Municipal Authority's act (§53 Pa.C.S. §5601, et. sec); be terminated.

WHEREAS, The Borough of West Newton, Westmoreland County, Pennsylvania, desires to take action approving the resolution to terminate the existence of The Municipal Authority of Borough of West Newton, Westmoreland County, Pennsylvania; and

WEREAS, The Borough of West Newton, Westmoreland County, Pennsylvania, desires to transmit to the Pennsylvania Department of State Corporation Bureau a Certificate of Termination and its approval of the termination of The Municipal Authority of The Borough of West Newton, Westmoreland County, Pennsylvania; and

WEREAS, The Borough of West Newton, Westmoreland County, Pennsylvania, approves The Municipal Authority of The Borough of West Newton requests to terminate its existence pursuant to §53 Pa.C.S. §5619

NOW, THEREFORE, BE IT RESOLVED by the Borough Counsel of The Borough of West Newton, Westmoreland County, Pennsylvania, as follows:

Section 1. Request to terminate an Authority

The Borough of West Newton, Westmoreland County, Pennsylvania, hereby approves, by this resolution, the request of The Municipal Authority of The Borough of West Newton, Westmoreland County, Pennsylvania, to terminate its existence as a Municipal Authority under the Pennsylvania Authorities Act.


Section 2. Delivery of Certificate to Terminate

The Borough of West Newton, Westmoreland County, Pennsylvania, hereby authorizes and accepts the Certificate to Terminate and directs that the Certificate of Termination be presented to the Pennsylvania Department of State Corporation Bureau for its approval to dissolve The Municipal Authority of The Borough of West Newton, Westmoreland County, Pennsylvania, forthwith.


Section 3.
