ORDINANCE NO. 2021 - 2

AN ORDINANCE OF THE BOROUGH OF WEST NEWTON, WESTMORELAND COUNTY, PENNSYLVANIA ESTABLISHING RATES TO BE CHARGED FOR THE FURNISHING OF SEWER SERVICE BY THE SEWER SYSTEM TO THE CUSTOMERS OF THE BOROUGH; ESTABLISHING THE AUTHORITY TO ISSUES RULES AND REGULATIONS; ESTABLISH PENALTIES FOR VIOLATIONS THEREOF.

WHEREAS, the Council for the Borough of West Newton is responsible for setting rates to be charged to customers of the Borough's sewage system; and

WHEREAS, the Council for the Borough initially adopted Ordinance No. 1974-11 which has been amended by Ordinance Nos. 1992-5, 1996-6, 1999-4, and 2005-6, and

WHEREAS, the Council for the Borough is desirous of changing said rates.

NOW THEREFORE, BE IT ORDAINED AND ENACTED, and it is hereby enacted by the Borough Council for the Borough of West Newton, Westmoreland County, Pennsylvania, as follows:

Section 1. Schedule of Rates.

The sewer usage rates for the Borough of West Newton shall be amended from time to time by Resolution of the Borough Council.

Section 2. Billing.

Bills for said sewer services shall be rendered in a manner and in the form to be prescribed by the Borough or its authorized agent. All bills for sewer service shall be rendered to the property owner, or, after proper arrangements, to the tenant of the premises to which sewer service is furnished. However, the property owner of the premises shall in all cases be liable for the payment of such bills.

Section 3. Rules and Regulations.

The Borough Council shall have the ultimate responsibility for management of the sewer system and it shall issue such rules and regulations governing the use, operation and maintenance of said sewer system as from time to time shall be deemed necessary.

Section 4. Penalties.

The sewer rates and charges imposed hereunder shall be due and payable immediately upon receipt of the bill by the owner and shall be paid not later than the due date appearing on the bill. Said charges shall be subject to a five percent (5%) penalty if not paid within twenty (20) days from their due date. If not paid within sixty (60) days after said due date, the charge plus the penalty shall bear interest at the rate of one-half percent (1/2%) per month or any fraction thereof until paid. Payment must be actually received by the Borough by the due date appearing on the bill.

Section 5. Collections.

The Borough or its authorized agent shall collect and received all sewer rates and charges prescribed by this Ordinance.

Section 6. Effective Date.

The sewer rates imposed by this Ordinance and accompanying Resolutions shall become effective on January 1, 2022.

Section 7. Repealer.

All ordinances and resolutions or parts of ordinances or resolutions not in accord with this Ordinance are hereby repealed insofar as they affect this Ordinance.

Section 8. Severability.


The terms, provisions and applications of this Ordinance are severable. If any provision of this Ordinance or application thereof to any person or circumstance is held invalid, such holding shall not affect the remaining provisions of applications of this Ordinance. The remaining provisions and/or applications of this Ordinance shall remain in full force and effect without the invalid provision or application.



RESOLUTION NO. 11 - 2021

A RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF WEST NEWTON, WESTMORELAND COUNTY, COMMONWEALTH OF PENNSYLVANIA, LEVYING THE TAXES UPON REAL PROPERTY LOCATED IN THE BOROUGH OF WEST NEWTON AND FIXING THE MILLAGE RATE AT 18 MILLS FOR PROPERTY TAXES FOR THE YEAR 2022

WHEREAS, Borough Code Section 1310.1 permits the Borough Council of The Borough of West Newton to adopt a resolution setting the real estate taxes of the Borough rather than adopt an ordinance where there is no tax rate increase over the previous year.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Borough of West Newton, Westmoreland County:

Section 1. Levy of Taxes.

The Borough Council for the Borough of West Newton hereby levies a tax on all real property within the Borough of West Newton subject to the taxation for the year 2022 as follows:

Tax Rate for General purposes at the sum of 18 mills on each dollar of assessed valuation, or the sum of .01800 per One Hundred (\$100.00) of assessed valuation of real property subject to taxation within the Borough.

Section 2. Repealer.

Any previous Ordinance or Resolutions, or any part thereof, which conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

Section 3. Effective Date.

This Ordinance shall enter into effect for the 2022 year beginning on January 1, 2022.
