

Regular Meeting
March 10, 2020

The regular monthly voting meeting of West Newton Borough Council was held on Tuesday, March 10, 2020 in Council Chambers, 112 South Water Street. Council President Charlie Krasnevich called the meeting to order at 6:30 p.m. Councilmembers Tony Berarducci, Gary Johnson, Charlie Krasnevich, Brenda Maleski, George Molovich and Dan Palfey called present during roll call. Mayor Mary Popovich, Solicitor Sam Dalfonso and Engineer Ryan Contestabile were present.
